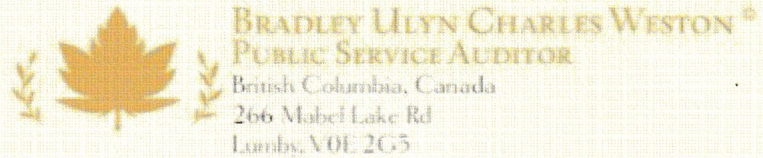

RE : APPEAL - VERNON FILE No. 55450 & OVERDUE BILL

Good Day SHAWNA,

On Monday, April 11, 2022 at 10:00 a.m. MR. JUSTICE HORI Heard Vernon File No. 55450, the Supreme Court of BRITISH COLUMBIA Appeal for LAURIE LANGFORD'S decision made on the evening of November 22, 2021. Crown Counsel, JAMES BAGAN was Present and ACTING on behalf of the "Queen" attempting to dismiss the Appeal.

You have been billed since March 12, 2021 and have failed to pay your bills since which are now seriously overdue resulting in a 30% surcharge being applied each Month.
