NOTICE OF DECLARATION, ORDERS AND LIABILITIES
Amended March 11, 2021

Notice to Agent is Notice to Principal and Notice to Principal is Notice to Agent

DECLARATION

This Declaration serves as a statement of Facts and Affidavit from the Legal Entity, Bradley Ulyn Charles Weston who solemnly AFFIRMS to be True and Honest as stated:

Today, February 26, 2021 at 12:48 p.m. i entered MONASHEES WINE AND SPIRITS, located at 2901 30th Street, Vernon, British Columbia to deliver a Notice from British Columbia's Office of the Human Rights Commissioner regarding Exemptions to the Mandatory Mask Order in British Columbia.

Attached herein to this Notice, marked as Exhibit "A" is a copy of the Notice from British Columbia's Office of the Human Rights Commissioner regarding Exemptions to the Mandatory Mask Order in British Columbia.

i stood by the front door near the counter. i fully respected social distancing of 2 meters at all times, and politely asked to speak with the manager, Jackie the one i was there to serve Notice upon. i respectfully spoke with the manager on duty who only identified himself using the first name, "PETE". We talked for approximately 2 minutes and 45 seconds. At no point during this 2 minute and 45 second interaction was i asked to put on a mask or leave the store.

Without warning, or having a reason to do so PETE instructed a member of his staff, "KATRINA" to call the R.C.M.P. During the call with the Dispatcher PETE told me he is, "*calling the R.C.M.P to remove me from the store.*" At this point i still had not been asked to put on a mask or to leave the store. i commented that i will wait until the R.C.M.P arrive to which PETE replied, "*Yes, that will be wonderful.*"

PETE told his staff member to tell the Dispatcher, "*Tell them we have a Customer who refuses to put on a mask and refuses to leave the store.*" i responded by telling PETE i did not refuse anything as i was not asked to put on a mask or leave the store at any time prior to his staff member making the false 911 call. i advised PETE that i will wait for the R.C.M.P as to not be considered, "fleeing the scene".

i recorded the entire situation in audio and video to document the incident as my witness. At no point during my conversation with PETE did i raise my voice, swear, express belligerent behaviour or cause a disturbance of any kind. When PETE told me the Police were coming to remove me for no reason i said i will wait for them. His reply, "Yes, that will be wonderful", was his verbal consent for me to remain on premise.

At approximately 12:57 p.m. the Public Servant, CST. S MIRANDA 64056 entered the store and made contact with my Character, Bradley Ulyn Charles Weston. i said, "*Hi, how are you doing, what is your name and badge number?*" CST. S. MIRANDA replied, "*CST. MIRANDA*". i again asked for his badge number and he said, "*I will give it to you in a second, let's step outside.*"

i complied with the request to "step outside" without hesitation or restraint. We walked through the first set of double doors and CST. MIRANDA asked for my I.D. i told him i was not going to identify. After saying this he held the next set of doors shut, not allowing me to exit. Now holding me against my will and restricting my movement he said, "*We are going to have a chat for a second and you are going to be arrested for causing a disturbance, we can chat right now for a minute and if you are going to be hostile i can put you in handcuffs, you can wait in the back seat and we will have a chat.*"

CST. CASTON 56864 arrived and CST. MIRANDA opened the door giving me little room to respect social distancing. i told CST. MIRANDA at this point that i was trying to respect social distancing to which he responded, "*That's great*" and he walked out with me. CST. MIRANDA made a Claim saying i was "*yelling and being belligerent.*" i responded by politely advising the two Public Servants that i never once yelled. i asked who it was that said i was yelling. CST. MIRANDA claimed the manager did. The two officers together then grabbed my arms and told me i am under arrest. i was handcuffed and placed in the back of CST. MIRANDAS SUV.

These two Public Servant R.C.M.P Members, CST. S. MIRANDA 64056 and CST. CASTON 56864 endangered my Life by ignoring social distancing and touching my Person with no cause or reason to have done so. The R.C.M.P are constantly in close contact with unknown People on a daily basis and could contract and spread the mysterious and elusive virus known as HCoV-19 or hCov-19, COVID-19 at any time.

i told the attending Public Servant R.C.M.P Members repeatedly that i have a lawful exemption and reason not to wear a mask as outlined in the EPA ORDER. i continually advised the Public Servants that i came to MONASHEES WINE AND SPIRITS only to deliver Notice of the Exemption Order.

EPA ORDER ON MASKS IN PUBLIC INDOOR SETTINGS:

As outlined in the [EPA mask mandate order](#):

There are exemptions for:

- People with **health conditions** or with **physical, cognitive, psychological or mental impairments who cannot wear one**
- People who cannot remove a mask on their own

- Children under the age of 12
- People who need to remove their masks to communicate due to another person's hearing impairment

In addition the Office of British Columbia's Human Rights Commissioner explicitly states:

- If a person claims a mask exemption, take them at their word. Proof should not be required.
- Business owners cannot be fined for allowing people without masks to enter their place of business.

Regardless of these facts, the Public Servant, CST. S. MIRANDA 64056 ignored the rules of the EPA ORDER and violated the **Laws** according to the Canadian Charter of Rights and Freedoms to which he took an Oath and swore to uphold by Discriminating against my Persons Medical Condition.

R.C.M.P. OATH OF ALLEGIANCE:

"Do you solemnly swear that you will be faithful and bear true allegiance to Her Majesty Queen Elizabeth the Second, Queen of Canada, her heirs and successors according to the Law, so help you God?"

R.C.M.P Members have a duty to respect and uphold the **Law** at all times.

CANADIAN CHARTER OF RIGHTS AND FREEDOMS:

Equality Rights

- **15.(1)** Every individual is equal before and under the **Law** and has the right to the equal protection and equal benefit of the **Law without discrimination** and, in particular, **without discrimination** based on race, national or ethnic origin, colour, religion, sex, age or **mental or physical disability**.
- **(2)** Subsection **(1)** does not preclude any **Law**, program or activity that has as its object the amelioration of conditions of disadvantaged **individuals or groups including those that are disadvantaged because of** race, national or ethnic origin, colour, religion, sex, age or **mental or physical disability**.

CST. S. MIRANDA belittled my Character, calling me a Child, an idiot and a moron saying he thinks he has authoritarian powers over my Person because he is a "police officer". i reminded him that he is a Public *Servant* and has a responsibility to ACT impartially and Professionally at all times, towards all Persons he encounters as outlined in the R.C.M.P CORE VALUES.

R.C.M.P CORE VALUES

The guiding principles of the RCMP are its core values: Honesty, Integrity, Professionalism, Compassion, Accountability and Respect (HIPCAR)

- **Honesty** Being truthful in character and behaviour.
- **Integrity** Acting consistently with our other core values upholding the ethical and social norms of the RCMP.
- **Professionalism** Having a conscientious awareness of our role, image, skills and knowledge in our commitment to quality client oriented service.
- **Compassion** Demonstrating care and sensitivity in word and action.

- **Accountability** There are two components of accountability. The first is the process of rendering an account to those from whom we derive our authority of what we did, why we did it, how we did it and what we are doing to improve performance or results. The second component is "answerability" - the obligation to provide information to others in our communities of interest with respect to our decisions, actions and results in light of clear, previously agreed upon understandings and expectations.
- **Respect** The objective, unbiased consideration and regard for the rights, values, beliefs and property of all people.

Following our conversation in the police car, i asked CST. MIRANDA why i was being detained and arrested. CST. MIRANDA told me i was under arrest for "*not listening*". i told him that does not constitute a Lawful arrest and he said we are heading to the police detachment where i will be held until i am given a date and time to appear in Court.

i was taken to the Vernon R.C.M.P detachment where i was introduced to the supervisor on duty SGT. C. ATTLESEY NC i/c "B" Watch. i explained my side of the Story to SGT. C. ATTLESEY, asked him for all the Public Servant names and badge numbers involved in this matter and i inquired about the audio and video in the police station and vehicles. i advised SGT. C. ATTLESEY that i want all audio and video evidence retained and secured informing him i will be making a FOIA request to obtain the footage.

CST. S. MIRANDA wrote two violations on TICKET # AJ16595780:

OFFENCE 1. DESCRIPTION: BELLIGERENT BEHAVIOUR, ACT: EMA, SECTION: S.6 (1), TICKETED AMOUNT: \$230

OFFENCE 2. DESCRIPTION: FAIL TO WEAR A FACE COVERING, ACT: EMA, SECTION: S.3 (1), TICKETED AMOUNT: \$230

The Provincial Government of British Columbia describes mask enforcement as set out below:

MASK ENFORCEMENT:

You could be subject to a \$230 fine if you:

- Do not wear a mask in an indoor public setting, ***unless you are exempt***
- Refuse to comply with the direction of an enforcement officer, including the direction to leave the space
- Engage in abusive or belligerent behaviour

Despite being **exempt** and having a legitimate reason not to be wearing a mask i was issued a fine for 'FAIL TO WEAR A FACE COVERING' described as being in accordance with SECTION 3 (1) of the EMERGENCY MANAGEMENT ACT.

EMERGENCY MANAGEMENT ACT, S.C. 2007, c. 15

Ministerial Responsibilities - General:

- **SECTION 3.** *The Minister is responsible for exercising leadership relating to emergency management in Canada by coordinating, among government institutions and in cooperation with the provinces and other entities, emergency management activities.*

Section 3 (1) does not define or outline any enforcement act or **Law** to issue a fine for "FAIL TO WEAR A FACE COVERING". No such **Law** exists and this constitutes an illegitimate fine that is not enforceable by **Law**. In the alternative, i am exempt by **Law** from wearing a face covering deeming my ticket unlawful.

When Public Servant, CST. S. MIRANDA 64056 entered MONASHEES WINE AND SPIRITS and asked me to “step outside” i immediately followed his direction to leave the space without hesitation or restraint.

i was Polite and Cordial towards both the store manager and the Public Servant R.C.M.P Members at all times. Regardless of these Facts i was issued a fine for BELLIGERENT BEHAVIOUR described as being in accordance with SECTION 6 (1) of the EMERGENCY MANAGEMENT ACT.

EMERGENCY MANAGEMENT ACT, S.C. 2007, c. 15

Ministers’ responsibilities

- **6 (1)** The emergency management responsibilities of each minister accountable to Parliament for a government institution are to identify the risks that are within or related to his or her area of responsibility — including those related to critical infrastructure — and to do the following in accordance with the policies, programs and other measures established by the Minister:
 - **(a)** prepare emergency management plans in respect of those risks;
 - **(b)** maintain, test and implement those plans; and
 - **(c)** conduct exercises and training in relation to those plans.

Section 6 (1) of the EMERGENCY MANAGEMENT ACT does not define or outline any enforcement act or **Law** to issue a fine for “BELLIGERENT BEHAVIOUR”. No such **Law** exists and this constitutes an illegitimate fine that is not enforceable by **Law**. In the alternative i did not express any negative behaviour which deems the ticket unlawful. .

i was released without being given a date to appear in Court as Public Servant CST. S. MIRANDA 64056 told me would happen. i was arbitrarily detained and arrested at 12:58 p.m. and held until 1:30 p.m. i was forced to walk back from the police station to my vehicle. i was arbitrarily detained for a total of 32 minutes with an additional 15 minutes of my time taken away when i was forced to walk back to my vehicle.

During the arrest i was unreasonably searched, was not informed of a legitimate reason for the arrest and denied my rights as detailed in the CANADIAN CHARTER OF RIGHTS AND FREEDOMS.

CANADIAN CHARTER OF RIGHTS AND FREEDOMS

Legal Rights

- **7.** Everyone has the right to life, liberty and security of the person and the right not to be deprived thereof except in accordance with the principles of fundamental justice.
- **8.** Everyone has the right to be secure against unreasonable search or seizure.
- **9.** Everyone has the right not to be arbitrarily detained or imprisoned.
- **10.** Everyone has the right on arrest or detention (a) to be informed promptly of the reasons therefor; (b) to retain and instruct counsel without delay and to be informed of that right;

Given the nature of the arrest and the circumstances that led to the arrest, Granted by the **Laws** of Canada, it is my Legal Right and Responsibility to hold the Public Servant R.C.M.P Members, including the other GOVERNMENT entities, such as, THE ROYAL CANADIAN MOUNTED POLICE, PROVINCIAL GOVERNMENT OF BRITISH COLUMBIA and THE CANADIAN GOVERNMENT involved in this matter accountable for their actions and to take Legal Action against these Public Servants and GOVERNMENT entities without delay as detailed in the CANADIAN CHARTER OF RIGHTS AND FREEDOMS.

CANADIAN CHARTER OF RIGHTS AND FREEDOMS

Enforcement 24.(1)

- Anyone whose rights or freedoms, as guaranteed by this Charter, have been infringed or denied may apply to a court of competent jurisdiction to obtain such remedy as the court considers

appropriate and just in the circumstances. (2) Where, in proceedings under subsection (1) a court concludes that evidence was obtained in a manner that infringed or denied any rights or freedoms guaranteed by this Charter, the evidence shall be excluded if it is established that, having regard to all the circumstances, the admission of it in the proceedings would bring the administration of justice into disrepute.

ORDERS

These Orders serve as Lawful instructions towards each PARTY NAMED in this Notice. Failure to Comply with these Orders, in whole, will warrant Legal Action as set out in the Liabilities Section of this Notice:

1. Cancel and revoke VIOLATION TICKET # AJ16595780 in its entirety within 10 Days of having received this Notice.
2. Issue a Notice to the Entire ROYAL CANADIAN MOUNTED POLICE force of BRITISH COLUMBIA instructing all Members to CEASE AND DESIST in enforcing the unlawful tickets described as Sections 3 (1) and 6 (1) of the Emergency Management Act against People who Claim Exemptions to wearing a mask, or a face covering, due to medical reasons as defined in the **EPA mask mandate order** and **Human Rights Code of British Columbia**.
3. Issue a Notice to the Entire ROYAL CANADIAN MOUNTED POLICE force of BRITISH COLUMBIA instructing all Public Servant R.C.M.P Members that they are to inform any business, Person(s) or entities calling to report individuals for not wearing a mask, or face covering, that Lawful Mask Exemptions are in effect under **Law** in the PROVINCE of BRITISH COLUMBIA, that they are to Respect People claiming Exemptions and the ROYAL CANADIAN MOUNTED POLICE have no Legal grounds to force an individual claiming a mask exemption to wear a mask, or face covering, or to leave a business for not wearing a mask or face covering as doing so is Discrimination, as defined under the Charter of Canadian Rights and Freedoms.
4. Issue an R.C.M.P Media Release informing the Entire General Public in the PROVINCE of BRITISH COLUMBIA about Lawful Mask Exemptions, the need to respect People claiming an Exemption and that there is no need to call the R.C.M.P on People claiming an Exemption.
5. Retain and Secure the audio and video footage from CST. S. MIRANDAS 64056 SUV R.C.M.P vehicle, and the audio and video footage from the VERNON R.C.M.P detachments holding area from February 26, 2021 between the time of 12:48 p.m. and 1:45 p.m.
6. Retain and Secure the audio from the 911 call, or VERNON R.C.M.P detachments line received in reference to this matter at approximately 12:51 p.m. on February 26, 2021.

If the PARTIES do not Agree, or fail to Comply with the ORDERS of this Notice, then within 10 Days of having received this Notice:

1. CST. S. MIRANDA 64056 must provide proof to his Claim in saying i was hostile, yelling, screaming and belligerent.
2. CST. S. MIRANDA 64056 must provide proof to his Claim in saying i do not have a reason for a Mask Exemption and that Medical Mask Exemptions do not exist in British Columbia.
3. CST. S. MIRANDA 64056 must provide proof to his Claim that Sections 3 (1) and 6 (1) of the Emergency Management Act allow tickets to be issued against Persons claiming Mask Exemptions.
4. SGT. C. ATTLESEY 46690 NC i/c "B" Watch and the VERNON ROYAL CANADIAN MOUNTED POLICE DEPARTMENT must provide the audio and video from CST. S. MIRANDAS 64056 SUV

R.C.M.P vehicle including the audio and video footage from the VERNON R.C.M.P detachments holding area from February 26, 2021 between the time of 12:48 p.m. and 1:45 p.m.

5. SGT. C. ATTLESEY 46690 NC i/c "B" Watch and the VERNON ROYAL CANADIAN MOUNTED POLICE DEPARTMENT must provide the audio from the 911 call, or VERNON R.C.M.P detachments non-emergency line, received in reference to this matter at approximately 12:51 p.m. on February 26, 2021. R.C.M.P File No. 2021 -3078.

LIABILITIES

These Liabilities serve as Notice to the Legal Actions which will be taken against all PARTIES NAMED who have been served this Notice by the Legal Entity, Bradley Ulyn Charles Weston if they fail to Comply with the ORDERS as set out above;

1. Granted i was unreasonably searched then arbitrarily arrested and detained for nearly an hour, i reserve the Right to take Legal Action in the Supreme Court of British Columbia against the arresting Public Servant R.C.M.P Members, CST. S. MIRANDA 64056, CST. CASTON 56864, their Commanding Officer SGT. C. ATTLESEY 46690 NC i/c "B" Watch and the GOVERNMENT OF CANADA entity, THE ROYAL CANADIAN MOUNTED POLICE, each of whom will be Personally fined and charged \$10,000 CAD, payable to my Legal Entity, Bradley Ulyn Charles Weston when found to be Guilty of such Claim.
2. Granted the fact that my Unalienable Rights were violated and my Legal Entity, Bradley Ulyn Charles Weston was Discriminated against by all PARTIES NAMED in this Notice, SGT. C. ATTLESEY 46690 NC i/c "B" Watch, CST. S. MIRANDA 64056, CST. K. HAMILTON 52115, CST. CASTON 56864 and THE ROYAL CANADIAN MOUNTED POLICE, i reserve the Right to take Legal Action in the Supreme Court of British Columbia against the PARTIES NAMED, each of whom will be Personally fined and charged \$10,000 CAD, payable to my Legal Entity, Bradley Ulyn Charles Weston when found to be Guilty of such Claim.
3. Granted i was issued illegitimate fines which are not written in **Law** or described in any Part of the Emergency Management Act, and issued such fines after i Claimed a medical reason for not wearing a face covering, i reserve the Right to charge each PARTY NAMED in this Notice \$500 CAD for each hour of my time spent dealing with this matter, including, but not limited to, the 1 hour of time spent in being arbitrarily detained and arrested including, but not limited to, the 4 hours of time drafting this Notice.
 - 3.1. Additionally, i charge for any costs accrued + 100%, related to dealing with this matter.
4. Granted the Fact that CST. S. MIRANDA 64056 and CST. CASTON 56864 potentially endangered my Life by ignoring social distancing and touching my Person with no cause or reason to have done so, i reserve the Right to charge both of these Public Servant R.C.M.P Members, including the GOVERNMENT OF CANADA entity; THE ROYAL CANADIAN MOUNTED POLICE, \$100,000 CAD each Personally, payable to my Legal Entity, Bradley Ulyn Charles Weston when found to be Guilty of such Claim.

Each PARTY NAMED must respond in writing within 10 Days of having been served this Notice. Failure to respond is considered an admission of the Facts as stated under the DECLARATION of this Notice. If no response is received immediate Legal Action will result which includes, but not limited to:

1. Dispute violation ticket No. AJ6595780
2. FOIA request all video and audio including, but not limited to, all file notes, R.C.M.P records, 911/dispatcher call(s) audio and all other related files related to R.C.M.P file No. 2021 - 3078 in their entirety

3. File a formal Complaint for Discrimination and Harassment with British Columbia's Office of the Human Rights Commissioner against the VERNON R.C.M.P detachment and each of the Public Servant R.C.M.P Members NAMED upon this Notice
4. File a formal Complaint with the Office of the Police Complaint Commissioner
5. File a BRITISH COLUMBIA SUPREME COURT case against the VERNON R.C.M.P detachment, THE ROYAL CANADIAN MOUNTED POLICE (R.C.M.P) GRC, and all R.C.M.P Members NAMED in this Notice of DECLARATION, ORDERS AND LIABILITIES

i, Bradley Ulyn Charles Weston, AFFIRM this NOTICE OF DECLARATION, ORDERS, AND LIABILITIES to be Absolute and True. No part of this NOTICE may be altered, copied, scanned, faxed, transmitted, Publicly released or shared by any other Party other than those who have received my permission in writing.
