In the event i am ever incarcerated or can no longer use my OWN voice and this Right of Agreement is put into effect, it is done so under the condition, the Living Man, Roy Vieira will Communicate and Record all matters of my incarceration and/or condition to my Council of 12 within the Sovereign - Common Law Court of the Land.

i, the Living Man, **Roy Vieira** Affirm and Agree to be the Living WoMan, Myah St. Pierre's Lawful Guardian & Legal Protector for 2 years from today's date. i make this Affirmation free from coercion or ulterior motives.


