**STATEMENT OF FACTS**

After reviewing all material Facts and evidence available, the Sovereign - Common Law Court of the Land has found you to be UnLawfully detaining and holding a Living Woman of the Land against her Lawful Will, Agreement and Consent.



On November 15th, 2021 a Member of the Royal Canadian Mounted Police Named Forsyth located the Living WoMan responding to the Name, **Myah St. Pierre** after the Police received a report from Myah's own Mother and tackled her to the ground with UnLawful FORCE causing significant bruising, swelling and cuts to her right knee.

Myah was taken to the Vernon Jubilee Hospital where she was admitted as a "Psychiatric Patient". A WoMan by the Name of Arlene M. Doll filled out and signed Form 6 of the "Mental Health Act" Claiming that a review panel reviewed the Case of Myah St. Pierre on November the 15th, 2021.

Arlene M. Doll signed the Document on December the 2nd, 2021, a full **17 Days after** her Hospital Admission. Myah was admitted to Hospital Involuntarily.

According to the Mental Health Act Involuntary admissions :

22 (1) The director of a designated facility may admit a person to the designated facility and detain the person for up to 48 hours for examination and treatment on receiving one medical certificate respecting the person completed by a physician in accordance with subsections (3) and (4).

The Admission Form used to UnLawfully Admit and Detain the Living WoMan, **Myah St. Pierre**, dated December the 2nd only states : "*our reasons to follow.*" The Document does not provide any valid reason or justification to hold **Myah St. Pierre**. It is noted that Arlene M. Doll was the only WoMan to sign Form 6 but claims to have signed on BEHALF of two others, a WoMan Named, Dr. Gillian Hodge and a Man Named, Gus Richardson.

Section (4) of the Mental Health Act also states that:

A medical certificate referred to in subsection (1) is not valid unless both it and the examination it describes are completed not more than 14 days before the date of admission.

The medical certificate dated December 2nd, 2021 is invalid and illegal as Arlene M. Doll has failed to fulfil all required criteria under the Mental Health Act. It is dated 3 Days beyond the required date of validation and provides no Lawful or Legal reason to hold the Living WoMan, **Myah St. Pierre**.

Arlene and other WoMen and Men ACTING as "Employees" working for the service CORPORATION, VERNON JUBILEE HOSPITAL are holding **Myah St. Pierre** against her Lawful Will, Agreement and Consent. In addition, the Document was not Physically witnessed and signed by members of the review panel.

Regardless of this information, service CORPORATION ACTS, Statutes, Rules, Policies and Mandates do NOT apply to Living WoMen or Men of the Land.

On December the 2nd, 2021 Myah drafted and signed a letter that she handed to Kevin Stevenson, a Man ACTING as a Psychiatrist at the VERNON JUBILEE HOSPITAL. Myah wrote, Quote:

*"i have not been provided with response from review panel December 2, 2021. Everything you do to me is under threat, duress and coercion! i am being held against my will.*

*Witnesses : Dawn May Somers, Heather Ann H., David E. Friesen and Nicolas Patatleo."*

The WoMen and Men who are UnLawfully detaining and holding the Living WoMan, **Myah St. Pierre** has been giving her injections and Pharmaceutical Drugs such as, but not limited to, Olanzapine, a typical antipsychotic used for the treatment of acute mania, schizophrenia, and other psychotic disorders in adults.

Myah has advised the WoMen and Men who are detaining her that she is not a Person, Patient, Citizen, Resident or Property and that she does *not* Agree or Consent to being given Pharmaceutical Drugs or Therapies of any kind. Myah has informed her captives that she is a WoMan of the Land and wants to be released effective immediately.

She has asked her Captives if they consider her to be their Property, if they have a contract with her that relinquishes her unalienable Rights or a Contract with the Service CORPORATION that they work for that claims Myah as Property and relinquishes her unalienable Rights. The reply to all three questions was, "No."

The Living Man, Roy Viera is the Lawful Guardian and Protector of the Living WoMan, **Myah St. Pierre**. Roy has Land and a Home for Myah to Live upon located at: 16 Candid Dr, LUMBY, BRITISH COLUMBIA and vows to provide all needs for Myah.

## CONCLUSION

**Myah St. Pierre** is an Affirmed Living WoMan of the Land.

The Living WoMan, **Myah St. Pierre**, is *not* a Person, Patient, Citizen, Resident or Property of another WoMan or Man, of the CORPORATE government of CANADA, or of the service CORPORATION Known as the VERNON JUBILEE HOSPITAL.

The WoMen and Men detaining and holding the Living WoMan, **Myah St. Pierre** has acknowledged and Agreed, she is *not* their Property and they do *not* have, nor can they produce a Contract that relinquishes her unalienable Rights as a Living WoMan of the Land.

The WoMen and Men detaining and holding the Living WoMan, **Myah St. Pierre** have declared it is not they who are holding her. They have stated it is the Mental Health Act that is detaining and holding her against her Lawful Will, Agreement and Consent.

It is impossible for a Fiction, such as the "Mental Health ACT" to detain and hold a Living WoMan or Man of the Land. In addition, the ACT that is being used as the excuse to hold the Living WoMan, **Myah St. Pierre** has been violated, as Section (4) of the Mental Health Act states:

*"A medical certificate referred to in subsection (1) is not valid unless both it and the examination it describes are completed not more than 14 days before the date of admission."*

The "Certificate" used to hold the Living WoMan, **Myah St. Pierre** is dated 3 Days beyond the required date of validation and provides no Lawful or Legal reason to hold the Living WoMan, **Myah St. Pierre**.

Service CORPORATION ACTS, Statutes, Rules, Policies and Mandates do NOT apply to a Living WoMan or Man of the Land.

The Living WoMan of the Land, **Myah St. Pierre** is being UnLawfully and illegally detained and held against her Lawful Will, Agreement and Consent, as such, the following Order has been issued:

**RELEASE ORDER**

**By the Order of the Sovereign - Common Law Court of the Land, established on this 12th Day of the 12 Month of the year 2021:**

1. On Tuesday, December 14th, 2021, Council for the Living WoMan of the Land, **Myah St. Pierre**, the Living Man of the Land, Brad Weston along with the Lawful Guardian and Protector of **Myah St. Pierre**, the Living Man, Roy Viera will give Notice of this here RELEASE ORDER to the Royal Canadian Mounted Police and seek their assistance to KEEP THE PEACE.
2. If no Member of the Royal Canadian Mounted Police is willing to KEEP THE PEACE they are Ordered to Stand Down.
3. "Employees" of the service CORPORATION Known as the VERNON JUBILEE HOSPITAL are to allow Council for the Living WoMan of the Land, **Myah St. Pierre**, the Living Man of the Land, Brad Weston along with the Lawful Guardian and Protector of **Myah St. Pierre**, the Living Man, Roy Viera to enter the VERNON JUBILEE HOSPITAL so they may speak with the Living WoMan, **Myah St. Pierre** in Private.
4. "Employees" of the service CORPORATION Known as the VERNON JUBILEE HOSPITAL are to allow the Affirmed Living WoMan of the Land, **Myah St. Pierre** to walk out of the VERNON JUBILEE HOSPITAL with her Council, the Living Man, Brad Weston alongside her Lawful Guardian and Protector, Roy Viera on Tuesday, December 14th, 2021.
5. **Myah St. Pierre** is to be allowed to walk out of the VERNON JUBILEE HOSPITAL unimpeded, free from Physical Contact, threats of Physical FORCE or harassment of any kind from any Staff or Security of the service CORPORATION Known as the VERNON JUBILEE HOSPITAL or R.C.M.P Members.
6. Any Staff or Security of the service CORPORATION Known as the VERNON JUBILEE HOSPITAL, or R.C.M.P Members who Impedes, Stops, makes Physical Contact with, threatens to use Physical FORCE or otherwise violates this Lawful Order, in any manner, personally accepts all Liabilities as stated herein:



## LIABILITIES

1. Any WoMan or Man who is 'Employed" as Staff or Security of the service CORPORATION Known as the VERNON JUBILEE HOSPITAL, or R.C.M.P Member who Impedes, Stops, makes Physical Contact with, threatens to use Physical FORCE, or uses Physical FORCE against the Living WoMan, **Myah St. Pierre**, her Council, the Living Man, Brad Weston or her Lawful Guardian and Protector, Roy Viera is Liable for \$2,000,000.00 CAD, or the equivalent of in whatever currency may be in effect at the date of and to have their Land assets ceased.
2. Any WoMan or Man who violates this here, Lawful RELEASE ORDER, and continues to allow the UnLawful and illegal detainment of the Living WoMan of the Land, **Myah St. Pierre** is Liable for \$500,000.00 CAD per Day, for each Day the Living WoMan, **Myah St. Pierre** is detained and held against her Lawful Will, Agreement and Consent retroactive to her first Day of UnLawful detainment, the date being November the 15th of the year 2021.






